COMMISSION IMPLEMENTING REGULATION (EU) 2018/700 AMENDING THE LISTS OF THIRD COUNTRY ESTABLISHMENTS FROM WHICH IMPORTS OF SPECIFIED PRODUCTS OF ANIMAL ORIGIN ARE PERMITTED, REGARDING CERTAIN ESTABLISHMENTS FROM BRAZIL

This letter is addressed to Border Inspection Posts and Chief Port Health Officers in England only.

I am writing to inform you about amendments to the list of third country establishments from Brazil, from which imports into the Union of specified products of animal origin are permitted.

This follows a significant number of serious and repeated cases of noncompliance due to the presence of Salmonella in poultry meat and poultry meat preparations originating from several establishments in Brazil.

There have been, subsequent cases of fraud found in Brazil concerning laboratory certification for meat and meat products exported to the Union.
