## Allowing non-Official Veterinarians (non-OVs) to carry out ID and physical checks on some third country imports that are subject to official controls at Border Control Posts (BCPs) in Great Britain

1. The Official Controls (Temporary Measures) (Coronavirus) (Amendment) Regulations

2021 provides a legal basis for the continuation and re-introduction of temporary easements to certain aspects of the delivery of official controls during the Covid-19 pandemic. Article 3 of the Regulation provides legal powers to introduce easements to allow official controls and other official activities to exceptionally be performed by one or more natural persons specifically authorised by the competent authority on the basis of their qualifications, training and practical experience.

- 2. Defra / FSA have decided to re-introduce the easement, which allows competent non-Official Veterinarians (non-OVs) to carry out ID and physical checks on some third country imports. This easement was in place last year but had to be withdrawn as the relevant Article 3 in the Commission Implementing Regulation, which provided the legal basis at that time, was omitted. The Article has been re-instated in the Official Controls (Temporary Measures) (Coronavirus) (Amendment) Regulations 2021.
- 3. Non-OVs may carry out ID and physical checks on following third country import:
  - **animal products**, supported by an OV who is onsite <u>or</u> through the use of remote technology such a phone camera.
  - low-risk animals such as invertebrates, reptiles and fish, supported by an OV onsite. One OV <u>must</u> be present at the BCP if handling animals due to animal health and welfare aspects.
- 4. The non-OV would have to be deemed competent by the competent authority / the lead OV based on his / her **qualifications, training and practical experiences**.







- 5. Checks on all other animals should continue to be carried out by an OV, given their high-risk status and animal health and welfare aspects.
- The frequency of checks should remain at levels set out in legislation (Retained Regulation (EU) 2019/2129), i.e. 100% documentary and 100% ID checks and minimum physical check frequencies specified in Annex 1 to that Regulation.
- 7. **BCPs should contact Defra / FSA** if they wish you implement this measure, providing following information:
  - justification for implementing the measure
  - the commodities, which would be checked by the non-OV
  - the name of the non-OV, who would be authorised to carry out the checks
  - the non-OVs qualifications, training and practical experiences
  - a declaration from the OV, stating his / her trust in the non-OVs qualifications, training and practical experience being suitable to carry out the checks
- Defra / FSA will decide on a case-by-case basis, taking into consideration the risk of the commodities in question and the information provided on the non-OVs qualifications, training and practical experiences, as well as any requirements under UK legislation.
- 9. The easement will be in place until further notice. Any changes to the policy will be announced via an OVS note to BCPs.

## Accepting scanned documents for some third county imports that are subject to official controls at Border Control Posts (BCPs) in Great Britain

- 10. Article 4 of the legislation provides a legal basis to introduce easements which allow documentary checks on third country imports to be performed on electronic copies of official certificates and attestations.
- 11. Defra and the FSA have agreed an easement, which allows BCP to accept scanned/e-documents for following commodities:
  - Products of animal origin (POAO) including fish and fishery products for human consumption <u>expect</u> those derived from porcine animals;
  - Animal by-products (ABP) except unprocessed ABPs of porcine origin;
  - Certain high-risk food and feed not of animal origin (HRFNAO) (commodities listed in Annex 2 of Retained EU Regulation 2019/1793).
- 12. The originals should be submitted by the operator as soon as technically possible.
- 13. This measure excludes the following commodities for which original documents are still required:
  - Live animals;
  - Germinal products;
  - Porcine meat (including fresh/frozen meat, minced meat and meat preparations);
  - Fresh unprocessed animal by-products derived from porcine animals.
- 14. Signed and scanned copies of Common Health Entry Document (CHEDs) / Export Health Certificates (EHCs) / Official Declarations or other accompanying documents can be accepted by BCPs without the original having to accompany the consignment upon entry into GB, provided that one of the following scenarios applies:
  - <u>Scenario 1:</u> Scanned copies are sent by email from the third country competent authorities to the BCP. Copies may be provided by the operator to the BCP if it is

clear in the chain of correspondence that they can verify the copy of the certificate was sent from the competent authority originally; in addition, the operator should also submit the scanned documents via the Import of products, animals, food and feed system (IPAFFS).

 <u>Scenario 2:</u> Scanned copies are sent by email from the operator to the BCP. In that case, the operator must copy in the third country competent authority (see list below for contact details); in addition, the operator should also submit the scanned documents via IPAFFS.

15. BCP should only accept scanned copies for consignments that:

- **do not** originate from countries **under current safeguard measures** for the commodity of concern;
- **do not** originate from **establishments under re-enforced checks** for the commodity of concern (also known as Intensified Official Controls);
- do not originate from operators with past history of concern, i.e. previous lack of cooperation with official controls or payments. BCPs should also assess any new operators based on intelligence from other BCPs.
- 16. BCPs should **request a declaration from the operator** to agree to submit original documents as soon as possible. **Ten (10) working days** should be the guide timescale. If no documents are received within this time period, the BCP should contact the competent authority in the exporting third country to seek the original documents (please see list of contacts at third country competent authorities below). If after a further ten (10) working days nothing has been received from the competent authority, then the BCP should contact either Defra or the FSA, depending on the commodity.
- 17. Should a BCP require **additional assurances** in relation to any documents, then the BCP **must contact the competent authority of the exporting third country**. If the BCP receives no reply within **five (5) working days**, the BCP may consider any supporting information provided electronically by the operator to the BCP and must also copy in the named responsible person at the competent authority of the exporting

third country.

- 18. BCPs should **track operator compliance** by recording the number of consignments that are received with copy documents supplied by the importer. This will ensure that all outstanding original documents can be followed up in due course.
- 19. In the case BCPs receive imports of products that are not covered by this easement and require original documentation, e.g. germinal products, porcine meat (including fresh/frozen meat, minced meat and meat preparations) and unprocessed ABPs of porcine origin not accompanied by original certificates, BCPs should contact Defra / FSA to request a policy decision on a case by case basis.
- 20. The situation will be monitored by Defra and FSA in liaison with BCPs. Further high-risk imports may be added to the list and thereby excluded from this policy, meaning that original documents will be required. Any changes to the international disease risk as a result of this policy will be escalated to the Coronavirus Special Animal Policy Group (APG) and the FSA's Immediate Response Group (IRG) for an immediate review of the wider policy.
- 21. This temporary measure will remain in place until further notice. Any changes to the policy will be announced via an OVS note to BCPs.

## Performance of remote documentary checks

- 22. Article 4 of the legislation provides a legal basis to allow BCPs to carry out remote documentary **from places other than the BCP**.
- 23. Defra / FSA have agreed to allow this easement. Documentary checks should still be carried out by an OV and at the **frequency set out in legislation**, i.e. 100% across all commodities.
- 24. The easement is in place until further notice. Any changes to the policy will be announced via an OVS note to BCPs.
