

## **APHA Briefing Note 03/24**

# Ban on XL Bully Dogs under the Dangerous Dogs Act 1991 – key dates

Date issued: 29 January 2024

### **Purpose**

To remind Official Veterinarians (OVs) of upcoming deadlines relating to the neutering and euthanasia of XL Bully dogs in line with their ban under the Dangerous Dogs Act 1991.

#### **Deadlines**

From 1 February 2024 it will be a criminal offence to own an XL Bully dog in England and Wales unless the owner has a Certificate of Exemption for their dog.

If XL Bully owners wish to keep their dog, they must apply for a Certificate of Exemption by 31 January 2024, and arrange for their dog to be neutered by the following dates.

If the XL Bully is:

- less than 1 year old on 31 January 2024, Defra must receive proof of neutering by 31 December 2024
- 1 year old or older on 31 January 2024, Defra must receive proof of neutering by 30 June 2024

If XL Bully owners decide not to keep their dog, they must arrange for their dog to be euthanised by a registered vet by 31 January 2024.

A contribution towards the associated costs will be available to these owners. Euthanasia carried out on XL Bullies after this date is not eligible for compensation, and vets should not complete the compensation form in these cases.
